# INFORMATION REGARDING THE PROTECTION OF THE PERSONAL DATA ACCORDING ART.13 AND 14 OF THE GUIDELINES (UE) 2016/679

**BONESI PNEUMATIK S.r.l.** headquartered in Via Robino 117 - 20025 Legnano (MI), Tel 0331.448000, e-mail <a href="mailto:raffaella.candiani@bonesipneumatik.it">raffaella.candiani@bonesipneumatik.it</a>, as **Data Controller** (following as the "Company" or the "Controller") gives the information relevant for personal data protection according to its web site available on line from <a href="https://www.bonesipneumatik.it">www.bonesipneumatik.it</a> (following as the "web site").

To this purpose it is underlined that this information is for its web site only and not also for other web sites possibly available by link or widgets mentioned on the web site, but relevant to external domain of the Controller or coming from mailing of messages.

## 1. CATEGORIES INVOLVED AND PERSONAL DATA HANDLED

The Controller handles the personal data of the physical people (identified or of possible identification) that visit or apply to the web site or that voluntary do actions on it connected to the Controller (following as the "Users").

The personal data handled are:

- a) Data of surfing: the on line system and the software procedures for the working of the web site, get during their normal activity, some personal data which transmission is automatic using Internet procedures of communication. In such category of data belong the IP addresses or the names in the domains of the computer terminals used by the Users, the addresses URI/URL (Uniform Resource Identifier/Locator) of the resources requested, the time of the request, the method used to submit the request to the server, the dimension of the file got as reply, the numerical code indicating the status of the reply given by the server (good, error, etc.) and other parameters relevant to the operating system and to the on line ambient of the users.
- b) Data communicated the mailing of such data is voluntary and done by filling and sending the form present on the web site and/or to the addresses of contacts of the Company or to the profiles/official pages on the social media (if such possibility is available): this means the acquisition of the data of the contact of the User necessary to reply and furthermore all the other personal data included in the form. Specific information will be published on the pages of the web site indicating the form or available for the supply of specific services.
- c) Cookies and other systems of recording: for more information about the kind of cookies used, their handling of use and purpose, see the cookies policy present on the web site, (following all, the "Personal Data").

# 2. PURPOSE OF HANDLING AND JURIDICAL BASES

The Controller handles the personal data acquired by the web site for the purposes and according the juridical bases mentioned in the following table:

1)	Due to a legal obligation connected to civil law, fiscal, administrative, community guidelines, codes or procedures approved by authorized Authorities or to follow the requests of the administrative or juridical authorities and in general of public people in the respect of the law.	To respect a legal obligation of the Controller.
2)	To defend its own rights, also by extra-juridical actions or also by third parties, and to prevent forbidden activities or the abuse of the web site (for illegal uses, like theft of identity, on line crimes, etc).	To get the lawful interest of the Controller.
3)	To allow the Users to visit the web site and to swift in the best conditions and to handle the requests received through the web site.	To execute contractual actions on request of the User.
4)	Limited to the surfing data of the Users, for the security of the Controller and to get statistics on the use of the web site (e.g. to know the pages and the average time spent for each page of the web site more visited) and to control and to handle the functioning of the web site and to improve its services.	To get the lawful interest of the Controller
5)	To handle the section contacts of the web site and therefore to reply to possible requests of the User got through the fill in possible form or by sending communications to the e-mail address of the Controller.	To execute contractual actions on request of the User

#### 3. **MANDATORY OF** RELEASING OF THE DATA **REQUESTED AND** CONSEQUENCES OF THEIR NON RELEASING

Apart from what specified regarding the surfing data (or in the specific policy, for the handling of the cookies), the user is free to supply its personal data (by possible specific form -on the pages available) to require information or to receive commercial communication.

It is understood that their non releasing, also partial, can prevent the Controller to do what requested by the User and the activity of communication, and the processing of possible connected obligations.

#### 4. METHOD OF THE HANDLING

The personal data will be handled by instruments either manual or on line, provided exclusively by authorized people and specifically instructed.





# 5. ADDRESSES/ CATEGORIES OF ADDRESSES OF THE PERSONAL DATA.

For the purposes indicated in the present information form:

- ✓ The Personal Data of the Users can be communicated :
- to the authorized people by the Controller at the handling (employs or consultants);
- to third people suppliers of services to the Controller (like suppliers of on line services, hosting provider, web editor, and companies or people that act on legal services, insurances) which will act , in case, as responsible of the handling;
- to companies or people charged to evaluate rights, interests, requests of the Controller coming from the relation with the Users;
- to the Government Administrations, juridical or administrative Authorities, public or private, also following of inspections or checks;
- to people that can get the data thanks to law dispositions or official standards.

Only the category of the addresses mentioned because it is continuously updated. To know the updated list of addresses, the Users can apply directly to the Controller, writing to the contact indicated at point 9 of the present information form.

### 6. TIMING FOR THE RECORDING OF THE PERSONAL DATA.

The personal data will be recorded by the Controller just the time necessary to the purpose for which they have been collected; more exactly the Controller will record:

- the data of the Users (indicated at point 1, sub a) for the timing of the surfing and no more than seven days, unless in the case of problems on the system, in which case they will be recorded until problem is fixed;
- the data communicated by the Uses (indicated at point 1, sub b):
  - i) as far as it concern the personal data communicated via the web site for the time necessary to satisfy the relevant request;
- the personal data which handling is necessary due to legal obligations for the time of the law;

and in any case, to the purposes indicated at point 2, n. 2, at the maximum for a period equal to the timing of expiration of the important actions increased of a period of six months, in order to insure the right of the defence of the Company with reference to possible future juridical or administrative disputes.

In any case, expired the relevant terms, all the personal data will be cancelled or become anonymous.

It is understood that the terms indicated can be extended in the cases which the further recording will be requested in occasion of possible checks, requested by the authorities or due to standards that can be applied.

# 7. TRANSFER OF PERSONAL DATA TO A THIRD COUNTRY OR TO AN INTERNATIONAL ORGANIZATION.

Within the purposes before mentioned, it is possible that the User's data can be transferred to UE countries.

### 8. RIGHTS

The Users, in some circumstances, can obtain from the Controller the following rights:





- **Right of entering**: allows the Users to obtain from the Controller that is running, or not, an handling of its personal data and to see its own personal data;
- **Right of modification**: allows the Users to obtain the correction/integration of the not correct /not complete personal data;
- **Right of cancellation**: allows the Users to obtain, in the cases admitted by the standards, the cancellation of its own personal data;
- **Right of limitation of the handling**: allow the Users to obtain, in the cases indicated at art. 18, point 1 of the GDPR, the limitation of the handling of its own personal data (by the evidence of the personal data recorded in order to limit their use in the future);
- **Right to the use of the data**: allows the Users, in the case the handling is done by systems authorized by the contract, to receive in a standard form, within the data supplied to the Controller, its own personal data and also the right to transmit such data to other Controller of the handling.

Furthermore, the Users have the right:

• to oppose to the handling of their own personal data for the purposes indicated at paragraph 2;

and, in case they think that the handling of their Personal Data done through out the web site is contrary to what mentioned on GDPR, **to present complain** thanks the art. 77 of the GDPR, to the authority of the Country member of the European Community in which the interested person has its own residence or place of work or where happened the violation of its right (in case such Country is Italy, the interested person can apply to the Authority for the protection of the personal data) **or to apply to legal actions** (art. 79 of the GDPR).
